**CONDITIONS GOVERNING IMPORTATION OF CATS**  
**Animal (National and International Movement of**  
**Disease Prevention) Regulations 1994**

This permit is granted subject to the terms and conditions relating to the importation of the above mentioned, set out in the regulations for the time being in force and to the following terms and conditions:

1. That the animal(s) are accompanied by health certificate signed by a Government Veterinary Officer stating that:
  - (i) The animal(s) were born in **Country** and have never left **Country**, if not born in **Country** or have left **Country** and returned, have been in **Country** for the previous six months.
  - (ii) The cat(s) are in good health and free from symptoms of any infectious or contagious disease.
  - (iii) During the twelve months immediately preceding the exportation there has been no Rabies among unquarantined animals in **Country**
  - (iv) The cat(s) have been vaccinated against Feline Rhinotracheitis, Panleukopenia, Leucosis, Calici, Chlamydia and Psictaci.
  - (v) The animal(s) have been treated for external parasites and for internal parasites with the approved broad spectrum Anthelminthic.

2. (a) The cat(s) was/were implanted with an I.S.O microchip, (as recorded above) followed by a Rabies Vaccination with an inactivated adjuvant vaccine, when the animal was not less than twelve (12) weeks

3. (b) On .....being at least three (3) weeks following the Rabies vaccination, a blood sample was taken from the said animal following microchip identification, and tested for antibody level at ..... laboratory\* ( See Annex 1 for list of approved laboratories.

Once the animal has a protective antibody level (>0.5Iu/ml) as established by the approved laboratory, the animal can be exported to St. Vincent and the Grenadines), **(Copy of the Laboratory result must accompany this certificate.**

4.The cat(s) is/are in good health and free from symptoms of any prescribed or any other infectious or contagious disease.

5.. The animal(s) has/have been treated for external parasites and for internal parasites with an approved broad spectrum anthelmintic.

The animal(s) must travel on a direct flight **(IF EXPORTATION IS FROM A RABIES ENDEMIC COUNTRY ONLY) TO ENGLAND** and not be accompanied by any dog or cat except from the same country.

Forty-eight (48) hours notice of arrival must be given. Phone 456-1111 Ext. 326 or (784) 457-2452

Animal(s) landed in St. Vincent and the Grenadines after 4:30p.m, Monday to Friday or weekends are subject to inspection fees.

This permit will unless previously revoked continue in force until three (3) months after being issued.
